VIOLATION

Failure to provide or maintain safe, adequate sanitary and proper service

PENALTY

P50 to P500 per day of operation, but not exceeding P100,000

VIOLATION

Failure to provide preventive measures, safety, and quality of shipping services under MC 114

PENALTIES

VIOLATION

Operating without required updated Certificate of Public Convenience (CPC)

PENALTY

P25 to P500 per day of operation, but not exceeding P100,000

VIOLATION

Operating a vessel or navigating a vessel without Certificate of Ownership

PENALTY

P500 to P16,000

.....

VIOLATION

Operating a vessel or navigating a vessel without Certificate of Philippine Registry

PENALTY

P200 to P3,000

.....

VIOLATION

Operating ships without the required updated Minimum Safe Manning Certificate (MSMC)

PENALTY

P50 to P5,00 per day, but not exceeding P500,000 & suspension / revocation of CPC / PA / SP

VIOLATION

Engaging ships in coastwise trade or protected or partly protected waters without updated Coastwise License

PENALTY

- First Offence:* P250 to P500
- Second Offence:* P500 to P1,000
- Third Offence:* N/A

VIOLATION

Engaging ships in coastwise trade or protected or partly protected waters without updated Bay & River License

PENALTY

- First Offence:* P150 to P300
 - Second Offence:* P250 to P500
 - Third Offence:* N/A

VIOLATION

Operating without updated Ship Station License

PENALTY

- First Offence:* P5,000
 - Second Offence:* P25,000; 30-day CPC suspension
 - Third Offence:* P50,000; CPC cancellation

VIOLATION

Life jackets, liferafts or boats, & lifebuoys not properly marked or not accessible for use

PENALTY

- First Offence:* P5,000
 - Second Offence:* P10,000
 - Third Offence:* P25,000 & / or SIRB suspension

- First Offence:* P10,000
 - Second Offence:* P20,000
 - Third Offence:* P25,000 & / or CPC cancelation
